# IMPRESSION FROM THE ESIL-AAIL CONFERENCE, THE HAGUE

On 14 October 2016, ESIL and the African Association of International Law (AAIL) coorganized a well-received conference on International Legal Aspect of Migration: African and European Perspectives. The conference generously funded by the Ministry of Security and Justice of the Netherlands and co-sponsored by the American Society of International Law (ASIL), brought together speakers from 12 countries, more than half of

them from Africa. In order to accommodate francophone speakers and attendees, English-French interpretation services were provided throughout the day. The conference was organized around four panels, covering Foundational Issues, including the drivers of irregular migration, African and European Perspectives on Recent "Safe (Third) Country " Debates, including the increasing securitization of migration and asylum law in Europe, Multilateral Dependencies and Migration Management, and The End of the Journey – International Legal Obligations Regarding Resettlement, Relocation, and Return. After a day full of engaged discussion among the panelist as well as the audience, the general sentiment expressed in the various concluding remarks was that hopefully this conference was not only the first time AAIL and ESIL cooperated, but that it may be the start of a series of cooperation between the sister organizations in order to foster fruitful and muchneeded dialogue in areas of mutual concern.

#### RESULTS QUESTIONNAIRE AND IG BUSINESS MEETING IN RIGA

The questionnaire on future activities of the IG, organized by the previous Coordinating Committee, has resulted in a variety of ideas. Through this newsletter we would like to give you a summary of the output and subsequent action.

Several topics for workshops and conferences were coined. Drawing upon several of the ideas, the IG Coordinating Committee is planning a conference on 'The Future of

International Migration Law' in the second half of 2017. International migration law is a multi-layered body of law, which is composed of an ever-growing number of norms relating to various branches of international law (e.g. human rights law, international refugee law, international labour law, international trade law, law of the sea, nationality law). The conference would look for synergies, coherence and new trends in the development of international migration law in the broad sense.

IG members also clearly indicated they would like to support the appearance of blogseries on certain issues on our website: local integration of migrants; financial aspects of migration; the state of the right to asylum in international law; migrants' international rights to education; relocation and resettlement to name just a few.

Some members proposed the idea of visiting refugee camp and/or a reception center. The IG Coordinating Committee will look into whether it is feasible to organize a joint visit – perhaps as a side-activity to an IG event – and to invite IG members to participate.

The organizing of a student writing competition on topics pertaining to migration and refugee law was also proposed.

Lastly, the Coordinating Committee was able to meet with a few IG members at the ESIL Annual Conference in Riga (8 September 2016) where we organized an **IG** business meeting. There it was suggested that a European database on PhD's in migration and refugee law could be a useful tool and that the IG could play a role in catalyzing this. #### **RECENT PUBLICATIONS**

A new book, written by our IG member **Eric Fripp**, has been recently <u>published</u>, which is entitled *Nationality and Statelessness in the International Law of Refugee Status* (Hart Publishing, Oxford, 2016). The book focuses upon analysis of the international law regarding nationality and statelessness (now including applicable parts of international human rights and non-discrimination law) as this affects the law of entitlement to refugee status. Interest Group members receive a 20% discount (£70, £56, using the discount code CV7 at the checkout).

Another new book, edited by Rosemary Owens and Joanna Howe, entitled *Temporary Labour Migration in the Global Era: The Regulatory Challenges* appeared at Hart Publishing, Oxford. This collection of essays subjects the topic to a sustained sociolegal analysis on a comparative basis, critiquing the underpinning conventionally accepted as fundamental in this area.
