CANDIDATES FOR NEW COORDINATING COMMITTEE

Kristof Gombeer is a researcher at the Center for International Law at the Vrije Universiteit Brussel, Belgium. His PhD research focuses on the monitoring and protection of fundamental rights of migrants and refugees in the context of maritime operations in the Mediterranean. He previously worked as a research fellow at the Counter Trafficking unit of the IOM Regional Office for the Asia-Pacific, Bangkok. He holds an LL.M. degree in International Legal Studies from the New York University School of Law and a M.Sc. in International Relations from the London School of Economics and Political Science.

Tamas Molnar is adjunct professor at the Corvinus University of Budapest, Institute of International Studies on public international law and migration law. Since January 2015, he also works as chief international law advisor in th Deputy State Secretariat of Hungarian Minorities and Diaspora, Prime Minister's Office. In addition, he has be involved in ad hoc consultancy work for UNHCR on statelessness since 2010. He obtained his Ph.D. in public international law from the Eötvös Loránd University of Budapest (ELTE) in 2013 and graduated from the Université libre de Bruxelles, Institut d'Etudes européennes in 2006 (LLM on EU law) and the ELTE Law Faculty in 2003.

Tom Syring is a founder and former Co-Chair of the International Refugee Law Interest Group of the American Society of International Law and currently serves on the Norwegian Immigration Appeals Board. He has previously taught at the University of Oslo and at Boston University as a Lecturer in International Law and Visiting Fulbright Scholar. He has particularly published and lectured on issues at the intersection of international humanitarian law, international criminal law, refugee law, and human rights. His latest research includes a book (co-edited, with Susan Akram) entitled Still Waiting for Tomorrow: The Law and Politics of Unresolved Refugee Crises (CSP), and a forthcoming, coedited volume (with Richard Falk) on War, Occupation, and Refugees (Routledge).
